



## NOTICE

Seventh Sense People Development Solutions Pvt. Ltd. (Seventh Sense), conducted Initial Assessment Test (IAT) on 30/08/2018 and 31/08/2018. Out of 474 students in final year, 449 appeared in IAT. On the basis of results, following has been decided:

- (1) Students who did not appear in IAT are not eligible for further training and placement opportunities through Seventh Sense.
- (2) 53 students failed to qualify the IAT. Seventh Sense has expressed regret in training and providing placement opportunities to them. Accordingly, students not eligible for training and placement through Seventh Sense is in the list shown.
- (3) Seventh Sense has agreed to provide training and consequently placement opportunities to qualified students. Only students who get trained shall be eligible for placement opportunities. Training would not incur any cost to students provided attendance is greater than 95%. If attendance in training falls short of 95%, cost of training would be adjusted from student's caution money, for which students shall submit declaration in prescribed format.
- (4) Students are required to submit the declaration form by 19<sup>th</sup> September 2018 to respective HOD's.
- (5) Phase 1 of training is expected from 8<sup>th</sup> to 13<sup>th</sup> October 2018.
