Brief History and Background:

It is approved by AICTE, New Delhi and affiliated to Dr. APJ Abdul Kalam Technical University, Lucknow, Uttar Pradesh. Presently we have the following undergraduate programs in B. Tech.- CSE, CSE (Artificial Intelligence), CSE (Data Science), IT and post graduate program in MCA. It's B.Tech. - CSE and IT disciplines are NBA accredited braches. ABESIT is also recognized as a Scientific and Industrial Research Organization (SIRO) by the Department of Science & Technology, Government of India. ABESIT has an Internal Quality Assurance Cell (IQAC) that was established on 15/12/2022 as per guidelines of NAAC.
